### CONTRACT AGREEMENT

WHEREAS the customer desires that the contractor should provide Support and Maintenance Services hereinafter called the "Services"

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Contract Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the terms & conditions of the contract agreement hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Contract Agreement.
- In consideration of the payments to be made by the customer to the contractor as hereinafter mentioned, the contractor hereby covenants with the customer to provide the services and remedying any defects therein in conformity with the provision of the Contract Agreement.
- 3. The customer hereby covenants to pay the contractor in consideration of the services and remedying of defects wherein the contract price or such other sum as may become payable under the provisions of this Contract Agreement at the times and manner prescribed by the Contract Agreement.

- 2. PITC will be owner of all templates, reports, design, records, application configurations, data and written material, products, specifications and drawings, source code and object code and other documents which have been created and developed by the contractor solely.
- 3. PITC will provide the software rights to contractor to carry out the above mentioned activities.
- 4. The agreed price will be firm and final and will not be escalated for any reason what so ever.
- If new taxes / duties are imposed / increased / reduced during the course of the Contract Agreement, the same will be adjusted accordingly by the customer (PITC).

### 1. Area of Work:

The contractor (MTI) shall be required to work in PITC, WAPDA House, Lahore for the Support and Maintenance of Software and across the country (Grid Sub-stations) for installation / shifting of AMR enabled meters. The Contractor shall also be responsible for repair/replacement of parts and Calibration of defective AMR Meters (warranty expired).

### 2. Payment:

- i. The payment of the Support and Maintenance Services will be made directly by Budget & Accounts Officer, PITC within thirty days or earlier from the date of receipt of invoice, on the production of following documents:
  - a) Sales Tax Invoice in Triplicate having NTN. Non Payment Certificate
  - b) Detail of Work Performed (Installation / Shifting of AMR Meters & Repair of Warranty Expired Meters)
  - c) Copy of Contract
  - d) Copy of Income Tax Exemption Certificate (if any)
- ii. Partial installation & part payments are allowed.
- iii. Invoices will be raised Quarterly.

### 3. Delivery Period / Commencement of Installation:

The Support and Maintenance Services will be started immediately from the date of signing of the Contract Agreement.

### 4. Validity of the Contract:

The validity of the Contract Agreement shall be valid for an initial period of 02 years from the date of signing of the Contract Agreement and automatically renewed till the termination notice from either parties.

### 5. General Conditions of Contract / Special Conditions of Contract:

This Contract Agreement is governed by the General Conditions of Contract (GCC) (Section – VI page No. 20-33) and Special Conditions of Contract (SCC) (Section – VII page No. 34-38) as mentioned in above referred RFP.

### 6. Laws Governing the Contract:

The Contract Agreement shall be governed by the Laws of Pakistan as amended from time to time.
